Day Camp Sponsorship Agreement

A sponsorship is a voluntary association of a Girl Scout Council and a community organization. We believe that one way to provide Girl Scouting to girls is through Day Camps sponsored by organizations whose ideals and objectives are in accord with those of the Girl Scout movement. The written sponsorship agreement is intended to promote close cooperation between the council and the sponsoring group through the interpretation of the responsibilities of both organizations.

Sponsoring Group Responsibilities

1. Adhere to national and local Girl Scout policies and standards.
2. Ask members to share hobbies and special interests with the Girl Scout Day Camp when requested by the leader.
3. Assist the troop in providing a meeting place that conforms to Girl Scout policies and standards.
4. Methods of sponsorship could include a financial donation, materials donation or a meeting place.

Girl Scout Responsibilities

1. Provide and administer the Girl Scout program within the framework of national policies and standards.
2. Interview interested adults including those suggested by the sponsorship group, and select those who meet Girl Scout qualifications.
3. Provide opportunities for Girl Scouts to meet other girls in a variety of activities.
4. Keep the sponsor informed about current Girl Scout activities and trends.

As pointed out through the interpretation of responsibilities listed above, there is no financial obligation on the part of the sponsor. However, a sponsor may give financial aid should they desire to do so. Volunteers may accept donations (in-kind and cash) valued at \$250.00 or less on behalf of the Council. Checks may be deposited directly into Troop or Service Unit accounts. Volunteers are responsible for providing donors with receipts. Donations at \$250.00 or more must be submitted to the Girl Scouts of Montana and Wyoming Headquarters. The Council will process the donation, provide thank you letter, and issue the Day Camp Director a check in the full amount of the donation.
