This year we are excited to move back to Digital Cookie! This Cookie Management System will help your Girl Scout meet and exceed their goals and really "Own Their Magic!"

Setup Your Digital Cookie Account:

- 1. Caregivers, on January 30th, look for an email from email@email.girlscouts.org to get your Girl Scout's site set up in Digital Cookie.
- 2. Don't forget to personalize your site with your goal and a profile photo/video! (optional) **Share Your Digital Cookie Link:**
- 1. Share your goals with customers through your Digital Cookie site.
- 2. Add customer contacts in Digital Cookie.
- 3. Share the Digital Cookie Link with family and friends via text, social media, and more!

Important Notes:

- Caregivers accept financial responsibility for all products and money collected and understand that the product ordered cannot be returned. The Troop is responsible for providing receipts for all transactions and you should retain copies.
- Understand all money earned is the property of GSMW and is not to be retained by any one individual. GSMW will take the necessary steps to recover outstanding balances.
- Customer orders over \$200 must be paid by cash or credit card.
- Camp Credit: Cookie balances must be paid by May 20th, 2024 to retain the Camp Credit. The credit must be used in 2024.
