Payment Policies & Refunds

Early Bird Registration Period

- Early bird registrants must pay the full early bird registration fee upfront in order to take advantage of the discounted rate.
- Early bird registrants may, within 48 hours of registration, cancel a registration without penalty (registrants
 will receive a full refund). If a cancellation occurs after 48 hours and is prior to Monday, May 1, 2023, 50% of
 the registration fee will be refunded.
- No refunds will be given after Monday, May 1, 2023, at 11:59 p.m. ET.
- Group packages are a single order and may only be canceled or refunded for all registrants included in that
 group package. Individual registrants in a group package who need to cancel are not eligible for a refund but
 can request a substitution. Please refer to the substitution policy below.
- Early bird registrants who cancel after the 48-hour grace period will receive a 10% off promo code to use for one individual registration to the 2026 Girl Scout Convention.

General Registration Period

- · A non-refundable deposit of \$100 per registrant is due at the time of registration.
- Registrants may, within 48 hours of registration, cancel a registration without penalty (registrants will receive
 a full refund). If a cancellation occurs after 48 hours, registrants will not be refunded the \$100 nonrefundable deposit. To cancel within this 48 hour window, please email convention@girlscouts.org to receive
 the full refund.
- During the general registration period, registrants have an option to make partial payments. Registrants can log in to the registration system at any time to make payments towards their remaining balance.
- Final balance for all registrations is due before the registration deadline on June 2, 2023, at 11:59 p.m. EST.
- Registrants who do not complete final payments or do not request a refund by the June 2, 2023, deadline will forfeit 100% of their completed payments and registrant's hotel reservations will be cancelled and forfeited.
- Prior to Monday, May 1, 2023, registrants will receive a 50% refund of all payments made, minus the \$100 non-refundable deposit per registrant.
- No refunds will be given after Monday, May 1, 2023, at 11:59 p.m. EST.
- Group packages are a single order and may only be canceled or refunded for all registrants included in that
 group package. Individual registrants in a group package who need to cancel are not eligible for a refund but

Hotel Reservations & Refund Policy

- Each individual room reservation must be confirmed and guaranteed by the registrant with a deposit equal

- Should a registrant cancel their hotel reservation, a refund of the deposit and/or cancellation fees will be in accordance with hotel general policy at that time. Currently, a refund is given if an individual's reservation is canceled at least five days before arrival.
- The remaining balance for hotel rooms is due upon check-in to the hotel.
