

2027 Camp Registration

Frequently Asked Questions

We're excited to announce that beginning in 2027, camp registration will move from April to January.

What is the new 2027 timeline for camp registration?

Camp registration will look like this:

- Priority* Camp Registration:
Begins January 6 at 9:00 AM
- Camp Registration for Everyone:
Begins January 13 at 9:00 AM

Why is camp registration moving?

- Earlier registration gives families more time to plan for adding Girl Scout camp to their summer plans and brings us in line with registration periods other camp and youth organizations follow.
- Moving registration also adds more time for families who select a payment plan as a payment method.
- More time = lower payments across several months instead of just two or three months.

When will the camp guide be available?

- You can expect to see the 2027 Camp Guide on our website sometime late Fall 2026.
- All Girl Scouts will still receive a copy in the mail before camp registration begins in January.

Will payment plans still be available?

- Yes! Earlier camp registration adds more time for families who select a payment plan as a payment method.
- More time = lower payments across several months instead of just two or three months.

Will financial assistance still be available?

- Yes! A financial assistance application will still be available through the UltraCamp system.

Priority Camp Registration

What is Priority Camp Registration?

- Priority Camp Registration is a new reward included in the 2026 Fall Product Program that provides access to camp registration one week early (begins January 6 at 9:00 AM).
- Priority Camp Registration will replace the period of registration previously reserved for Camp Credit Earners**.

How can my Girl Scout earn Priority Camp Registration?

- Your Girl Scout can earn Priority Camp Registration by participating in the Fall Product Program and reaching the \$650+ reward level.

Will I be notified once my Girl Scout earns Priority Camp Registration?

- If your Girl Scout has earned Priority Camp Registration as a reward during the Fall Product Program, you will receive an email from the Product Program team at the beginning of January 2027 that will include step-by-step instructions for registration beginning on January 6 at 9:00 AM.
- During the Priority Camp Registration period, all registrations will be reviewed to confirm that only eligible earners have registered.



Camp Credit Earners

Will my Girl Scout still have the opportunity to earn camp credit during the cookie season?

- Yes! Camp Credit will still be a reward Girl Scouts can earn during the 2027 Cookie Program.

Will I need to pay a deposit when we register?

- Yes, all registrants will be required to pay the non-refundable \$50 deposit at the time of registration.

If we've already paid for my Girl Scout's camp, can she still earn the camp credit reward during the cookie program?

- Yes! If your Girl Scout earns AND selects the camp credit reward option, the credit will be added to your UltraCamp account in late April.
- If you've already paid for some of your camp, GSMW will provide a refund up to the amount of camp credit your Girl Scout earns during the cookie season and any remaining balance, if any, will be due.

What will the camp credit earner registration process look like now?

1. You will register either during the Priority Camp Registration period (if your girl earns that reward during the Fall Product Program) or the Camp Registration for Everyone period.
2. Choose your girl's camp as you have in previous years and pay the non-refundable \$50 deposit.
3. Choose a payment method and complete the registration process!

Important note: If your girl sets a goal of earning camp credit during the cookie program, you can choose a delayed payment plan that will delay the start of your monthly payments until May 1, which will be after earned camp credit is added to your UltraCamp account in late April and applied to your balance due.
