How To Get Started

- Juliettes must be registered for the 2024-2025 membership year and any adult who will handle money and product with their Juliette must also have a current membership and background check on file.

- Let GSMW know your Juliette will be participating by completing the [Juliette 2024 Fall Program Permission](#) Form before September 27th.
- Review the materials in your mailed packet.
- If your Juliette is a Cadette, Senior or Ambassador would like to opt out of rewards for an additional 2% in proceeds, email bridgetm@gsmw.org by September 27th.
- Set up your Juliette's online sale site starting September 27th.

How To Submit Your Order

All Juliettes that participates in the 2024 Fall Program **MUST** submit the online Juliette 2024 Fall Program Order Form no later than **Sunday October 20th at 11:59 pm**. This form collects the following information that GSMW needs and is found at www.gsw.org/juliettesfallprogram.

- Paper order card totals, if applicable
- Your shipping address for product and rewards
- Reward choices so GSMW can order the rewards your Juliette has chosen
- Information needed to set up Clover Go app for debit/credit cards if desired
- Caregiver signature

Product Delivery

- Product will be delivered to your area November 11th-19th. You will receive an email letting you know how you will get your product.
- Checks can be made out to GSMW.
- GSMW does not accept checks for more than \$200 or cover NSF fees for checks dated more than 30 days.

How to Submit Your Money

Your balance is due **Tuesday December 10th**. You can submit your balance in the following ways:

By Mail	<ul style="list-style-type: none">• Do NOT mail cash• Mail with the Juliette Deposit form found in your packet or at www.gsmw.org/juliettesfallprogram• Mail with a tracking number• You can call GSMW with a card # to pay for the amount collected in cash or include a check/money order for the cash amount• You will receive an email when we receive your money
First Interstate Bank	<ul style="list-style-type: none">• Deposit cash and checks into the GSMW FIB depository account # 153974• Be sure to get a deposit receipt• Complete the Juliette First Interstate Bank Deposit form found at www.gsmw.org/juliettesfallprogram within 2 business days uploading a picture of the deposit receipt
In Person	<ul style="list-style-type: none">• Bring your cash and checks to the GSMW office in Billings (no appointment required) or Great Falls (appointment required)• Bring a completed Juliette Deposit Form found in your packet or at www.gsmw.org/juliettesfallprogram
