- Paper order card totals, if applicable
- Your shipping address for product and rewards
- Reward choices so GSMW can order your Juliette's rewards
- Caregiver signature

# Product Delivery

- Product will be delivered to your area November 17<sup>th</sup>-25<sup>th</sup>. You will receive an email letting you know how you will get your product.
- Checks can be made out to GSMW.
- GSMW does not accept checks for more than \$200 or cover NSF fees for checks dated more than 30 days.



# Product Payment

Your balance is due Tuesday December 16<sup>th</sup>. You can submit your balance in the following ways:

<b>By Mail</b>	<ul style="list-style-type: none"><li>• Do NOT mail cash</li><li>• Mail with the Juliette Deposit form found in your packet or at <a href="http://www.gsmw.org/juliettesfallprogram">www.gsmw.org/juliettesfallprogram</a></li><li>• Mail with a tracking number</li><li>• You can call GSMW with a card # to pay for the amount collected in cash or include a check/money order for the cash amount</li><li>• You will receive an email when we receive your money</li></ul>
<b>First Interstate Bank</b>	<ul style="list-style-type: none"><li>• Deposit cash and checks into the GSMW FIB depository account # 153974</li><li>• Be sure to get a deposit receipt</li><li>• Complete the Juliette First Interstate Bank Deposit form found at <a href="http://www.gsmw.org/juliettesfallprogram">www.gsmw.org/juliettesfallprogram</a> within 2 business days uploading a picture of the deposit receipt</li></ul>
