Troop Due Dates to Share with Caregivers:

- ◆ All pre-orders must be submitted to the Troop by **February 15th at 11:59 PM.**
- ◆ Additional Girl Delivery boxes (Orders from Feb 12th – Apr 13th) requested from Troop, as needed, or by (but no later than) _____.

Troop Due Dates:

- ◆ Enter pre-orders by girl and order extra packages (additional sales, and Girl Delivery orders after Feb 12th) in Smart Cookies no later than **February 17th at 11:59 PM.**
- ◆ Create Initial Reward order in Smart Cookies through the Rewards tab no later than **February 17th at 11:59 PM.**
- ◆ Sign up for booths starting February 9th and enter individually Troop Secured Booth Requests in Smart Cookies 48 hours in advance for Council approval.
- ◆ **February 17th**, check the Girl Cookie Order Details Report in Smart Cookies for any additional packages needed for Girl Delivery for orders placed after February 11th. If you have not received requests for additional packages from Caregivers, you will want to verify they have all they need to fulfill Girl Delivery orders.

Troop Due Dates to Share with Caregivers:

- All money due to the Troop by _____ or fill out the Outstanding Balance Form online with all necessary documentation (signed receipts, collection attempts) by May 4th.
- Final Rewards choices/sizes submitted to Troop by _____ or the Leader will make the selection for the girl.

Troop Due Dates for Leader:

- Assign all extra packages (booth, additional sales, Girl Delivery orders after Feb 12th) to girls in Smart Cookies no later than April 15th.
- Record all girl payments (cash & check) in Smart Cookies in the Girl Orders tab no later than _____.
- If a Caregiver has not turned in all money due, fill out and submit an Outstanding Balance Form online before the Troop is paid in full or by May 5th.
- Deposit all money into the Troop bank account no later than _____ for the 1st ACH sweep.
