### Weekly Checklist

### No-Risk Cookie Pickups – Limited Time Only!

It's the final week of cookies and we have a great opportunity to help reach your goals!

Beginning TODAY April 6<sup>th</sup>, caregivers can pick up cookies from a Council Cupboard to have No-Risk Walkabouts or Booths! A No-Risk Cookie Cupboard allows you to return any unsold cookie cases or packages that you picked up by 7 PM\* on April 13, 2026, at no cost to you. This is a great opportunity to boost your sales during the final week of the Girl Scout Cookie Program without the worry of leftover inventory.

*\* Please note your local cupboard manager may need them back sooner than 7pm based on their availability.*

#### Key details:

- All returns must be made by 7 PM on April 13. No exceptions.
- Cookies returned must be out of the inventory you signed out during the No Risk promotional period April 6<sup>th</sup>-12<sup>th</sup>.
- Any cookies not returned by the deadline will be the financial responsibility of the person who signed for them.
- This is a first-come, first-served opportunity.

## Donated Packages

If your Juliette would like to donate her donated packages to the organization of her choice, you will request your packages from Council by [April 30 here](#). Requested packages will be picked up from a local Cookie Cupboard and we will communicate with you at the beginning of May when you can pick them up. If you choose not to request your donated packages, council will donate them on your behalf.

## Camp Credit Earners



If your Juliette earned Camp Credit you will receive an email on April 13 about redeeming your Camp Credit. Camp Credit earners can sign up for camp starting Wednesday April 15 at 9 am. Your balance must be paid by May 18, 2026 to retain the Camp Credit and the Camp Credit must be used in 2026.

First Interstate Bank	Deposit cash/checks into FIB account # 153974. Upload picture of deposit receipt to <a href="#">Juliette First Interstate Bank Deposit</a> .
By Mail	Mail checks (do not mail cash) with a tracking number and <a href="#">Juliette Deposit Form</a> to GSMW, 2303 Grand Ave, Billings, MT 59102.
By Phone	Call GSMW office at 406-252-0488 with a card number.
In Person	Bring it to the Billings GSMW office with a completed <a href="#">Juliette Deposit Form</a> .

## Using Juliette Funds

Your balance must be paid in full to use your Juliette Funds.

### **Camp**

Early Bird camp registration opens April 22 at 9am. You can use your cookie proceeds (Juliette Funds) to pay for camp. To do that, [register](#) your Juliette for camp paying the \$50 deposit to secure her spot. Then complete the [Juliette Fund Request form](#), to let us know how much of your funds you would like to use to pay towards your balance. If you would like to be reimbursed for the deposit, please note that in the comments.

### **Other Requests**

All other Juliette Fund Requests can be made by completing the [Juliette Fund Request form](#). You can use your Juliette Funds for Juliette and Juliette Mentor memberships, camp/program registration fees, shop purchases, Girl Scout approved travel, community service projects and Highest Awards expenses.
